The appointed person training programme is designed to provide delegates involved in lifting operations with clear knowledge and understanding of relevant legal and practical requirements to develop the various lifting plans and risk assessments to ensure and execute lifting operations in a safe and controlled manner.

### WHO SHOULD ATTEND?

The course is designed for those responsible for the safe and efficient operation of lifting equipment and operations on onshore, offshore, or marine vessels. The course is useful for those who oversee lifting operations and manage lifting equipment and personnel, and it is relevant for riggers, crane operators, and others involved in lifting

operations who require a comprehensive understanding of the risks and best practices involved in these activities.

### WHAT ARE THE PREREQUISITES TO ATTEND?

Candidates are required to have prior experience working with cranes and lifting equipment, especially in an offshore environment. They should also have a good understanding of the regulations and standards that govern crane operations, including those specific to offshore environments.

Candidates should have good communication skills to complete lifting operations safely and an understanding of the technical aspects of crane operations. They may be required to hold a relevant crane operation qualification, such as crane operator certification of rigging qualification.



### WHAT IS THE DURATION OF THIS COURSE?

To provide delegates with a better knowledge and understanding of legal responsibilities and practicalities required to develop lifting plans and risk assessments to ensure safe and controlled lifting operations.

### WHAT WILL BE COVERED?

Delegates will be assessed in a mix of theoretical and practical elements. Practical exercises will be assessed on an ongoing basis and a theoretical exam is conducted at the end of the course. The key areas of focus include:

- Health and safety legislation
- Duties and responsibilities
- Offshore crane types and components
- Operation manual and logbook
- Risk assessment
- Slings and signalling.
