The stage 3 re-assessment ensures your crane operators can react quickly and effectively to emergency situations and reduce risk in your lifting operations.

Stage 3 re-assessments can be completed onsite at the delegates workplace or at our training centre using our offshore crane simulators.

Crane simulators complement rather than replace training on a real crane and are a great tool to validate continuous competence.

## WHO SHOULD ATTEND?

Delegates who hold a recognised and valid stage 3 qualification gained at an offshore workplace.

## WHAT ARE THE PRE-REQUISITES OF THE ASSESSMENT?

Delegates are required to provide evidence of a valid stage 3 certification which will be validated before the re-assessment goes ahead.

## WHAT IS THE DURATION OF THIS ASSESSMENT?

The assessment typically takes around six hours and can be booked with morning or afternoon sessions.

## WHAT ARE THE AIMS OF THE ASSESSMENT?

To validate ongoing competence and ensure the delegate meets the required standards for safe offshore crane operations.

## WHAT WILL BE COVERED?

The simulator projects a virtual offshore environment, with assessment of realistic static and dynamic lifting operations designed to suit the operator's experience.

The delegate is also challenged to respond correctly to emergency situations and be able to demonstrate underpinning knowledge of safe crane operations.

## WHAT CERTIFICATE DO ATTENDEES RECEIVE ON COMPLETION OF THIS ASSESSMENT?

Delegates are issued a certificate for Altrad Sparrows Offshore Crane Operator Standard Stage 3 which is valid for two years. The re-assessment must be completed on a two-yearly basis to ensure ongoing competence.
